2019 Stakeholders Report with 2020 Comment

Dear Friends of Land Preservation Trust (LPT),

First, thanks to all who have, with dedication and generosity, made progress possible – with special thanks to Ann Jones, Danielle Oster, Anne Litz, and events coordinator, Alix Smith along with our Board members and volunteers. 2019 and YTD 2020, while challenging on many fronts, have been a good time for Easements. Significant acreage has been added; thanks to the continued success of the Piney Run Rural Legacy program, administered by LPT. The ambitious goal of connecting 20,000 acres by 2020 was surpassed thanks in combination to Piney Run Rural Legacy and State and County programs, as well as a few key donated easements.

Progress, in the form of approved grants, has been made toward the goal of becoming a catalyst for ecological restoration including stream restoration, research and education, and conservation resource mapping. While the belt tightening required by COVID slowed some of our stewardship efforts, plans are to reinvigorate this essential work in 2021.

Shawan Downs had an exciting time, albeit with fewer equine events in 2020. The Spring Schooling and the Fall Point to Point were well received and good weather brought walkers, runners, and birders to our field and forest while the farmers were able to get two good hay cuttings on 150 of the acres. Shawan exemplifies the convergence of many aspects of local land conservation. While serving as the eastern entrance to our valleys, it is a place for nature, for a variety of horsemen, and for our community.

Our friends were generous in 2019 and in 2020 we, thus far, have met our income expectations while keeping our expenses below our post COVID budget. Many donors stepped up early in 2020 while we worked at "belt tightening". Others sent in donations mid -year and many "LPT friends" made it possible to organize the Fall Point to point. We were fortunate recipients of two government grants to support LPT payroll. Stepping back, the results of the 2019 fiscal year are included as part of this report and on our website.

Behind the scenes, the governance committee was busy shoring up fine details and with the addition of two new board members, we have a far more robust and active committee structure. We will continue to strive to build our capacity to think strategically and execute plans with energetic intention.

Thank you for all you do for LPT, and for your generous attention. We all look forward to 2021.



We enjoyed a full card of equine events in 2019, including The Legacy Chase to benefit GBMC, The Green Spring Valley Hounds Point to Point, The MCTA three day event, Maryland Jr. Hunt Cup, and follow up schoolings on the race and events courses. In 2020 we created COVID sensitive opportunities for schooling in the Spring and transitioned the Legacy Chase to a Fall point to point. Both were well received and successful ventures with the added benefit of the chance to school and compete for many apprentice jockeys. In addition to our traditional equestrian events, COVID also provided an opportunity to share our 250 acres with numerous walkers, joggers and birders. During the quiet months we were able to restore the farm shop and cottage, and rent farmland for hay cuttings to Branchwater Farms. It is our hope is to continue to provide opportunities for horses to compete and to share the property with our community. We look forward to seeing you in 2021.
